**RESOLUTION TO ADOPT BALLOT LANGUAGE
FOR EMERGENCY MEDICAL SERVICES (AMBULANCE) MILLAGE**

WHEREAS, the Bertrand Charter Township Board wishes to provide emergency medical services to the people of the Township, and

WHEREAS, Charter Townships may impose and levy ad valorem property taxes to finance lawful public services and expenditures, including emergency medical services as authorized by the Michigan Constitution of 1963 and other state statutes; and

WHEREAS, the Bertrand Charter Township Board wishes to request an extra-voted millage of up to 0.25 mills (one quarter of one mill) to be used exclusively for emergency medical services, including ambulance services.

NOW, THEREFORE, BE IT RESOLVED that the Bertrand Charter Township Board, Berrien County, Michigan, approves the following millage ballot question language and directs the Clerk to submit it to be placed on the August 6, 2024, election ballot:

EMERGENCY MEDICAL SERVICES (AMBULANCE) MILLAGE

In support of Ambulance and emergency medical services in Bertrand Charter Township, Berrien County, Michigan, shall Bertrand Charter Township levy an extra-voted Ambulance millage of .25 mills (one quarter of one mill), which is equal to \$0.25 (25 cents) per \$1,000.00 (one thousand dollars) of taxable valuation of real and personal property subject to taxation in Bertrand Charter Township? Said millage will be used to continue to provide Ambulance and emergency medical services in Bertrand Charter Township. Said millage, if approved by the electors of Bertrand Charter Township, will be levied for a period of three (3) years, starting in 2024 and ending in 2026. It is estimated that the levy will generate up to \$49,227.37 in the first year.


